1. Will there be a guessing penalty on the PARCC tests?

PARCC Response: No.

MC² Response: There is no penalty for guessing. Students should be encouraged to answer all questions to the best of their ability. Other valid methods for solving the problem can earn full credit unless a specific method is required by the item. If students make a computation error, they may still earn points for reasoning or modeling.

2. The PARCC practice tests are giving an immediate report of number correct/incorrect. Will the live test do the same?

PARCC Response: No.

3. I have been told that grading of the PARCC will take until September and maybe even December. Is this true? If so, why?

MC² Response: What MC² is hearing is that we may not get results until the fall because of the standards setting process that needs to happen with the first iteration of the PARCC assessments. We really do not have previous data yet to gauge student proficiencies. The data will have to be used to create the cut-scores and set the passing standards for this first round. In subsequent years, it should be quicker but this first year it will take longer to do that.

4. The practice PARCC tests are not loading the graphics. Is this a problem with PARCC or is it at my end?

PARCC Response: Your end.


5. On the PBA, will students be able to type the word “equals” instead of using the symbol during testing?

PARCC Response: Do mean like “3 + 4 equals 7”? It really depends on the question. If the question asks for an equation, then that is what is required.

MC² Response: It matters as to what part of the test item it is. One way to get to know what is allowed on the PBA is to actually take the PBA practice test (<http://parcc.pearson.com/practice-tests/math/>). This will help familiarize you with the tools available for students in the writing of their responses.

6. Is there a way for us to see the writing rubric that PARCC uses?

PARCC Response: In ELA? If so, yes. Check out: <http://www.parcconline.org/samples/item-task-prototypes> and refer to bottom of screen.

MC² Response: For math, go to the PBA practice tests (<http://parcc.pearson.com/practice-tests/math/>) to see the rubrics for all the practice items under *View Answer Keys*.

7. Doesn't the browser have a big impact? We have found that Internet Explorer (IE) has to be used, not Firefox or Google Chrome.

PARCC Response: Should work on all three browsers. Make sure that Java is updated. 8. Do we have any results from the recent infrastructure check on January 22? We had some challenges and I am wondering if other districts did, as well. Will this check be repeated?

Some of the issues identified include things such as error codes on the screen, connection issues, video players and drag-and-drop functionality. The solutions for these fall into several categories:

- **Local training/preparedness.** New documentation has been drafted to help test administrators find the appropriate resources and get quick answers to common issues.
- **Platform issues.** Pearson has adjusted/will adjust any issues that impact operational testing.
- **Manuals/documentation.** Documentation is being edited to include more step-by-step instructions for clarity.

9. If the tests are all the same, would having computers next to each other lead to sharing answers?

MC² Response: As per the PARCC Frequently Asked Questions about the PARCC Spring Administration, Updated January 14, 2015, pg. 9, #6 (<http://www.parcconline.org/sites/parcc/files/Frequently-Asked-Questions-about-Spring-1-14-15.pdf>), the training materials indicate that students must be separated by a reasonable distance. How is reasonable distance defined? Seating arrangements should prevent student collaboration, but School Test Coordinators and Test Administrators may use their professional judgment when setting up the testing room. Suggestions for seating arrangements can be found in Section 4.1 of the Test Coordinator Manual.

10. Will MC² be having a webinar in March? When?

MC² Response: We do know that this would be during the PBA testing window so we'll evaluate the effectiveness and efficiency of having a webinar at this time.
